5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. #### **Additional terms & conditions**

- 1) **SCOPE OF SUPPLY:** Supply of Ferric Alum Grade-IV confirming to IS-299(latest) at our Jaduguda Site, Unloading from truck and stacking at our stores /site stores /godown. Jaduguda is located approx. 25 KM away from Tatanagar Railway station.
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 3) **Delivery Schedule:** Material will be supplied as mentioned in delivery schedule. However delivery quantity in each lot may vary by 10%.
- 4) Unloading of material at site is under the scope of the work of the supplier.
- 5) Material should be in 20-25 Kg naked solid from lumps/HDPE bags.
- 6) Test certificate should be furnished along with each consignment. Sampling of each consignment shall be done at our end with grab sampling method and shall be analyzed in our lab. Our analysis shall be treated as final and binding to both.

- 7) The analysis value will be rounded off to the nearest integer. Decimal fraction above or equal to 0.5 shall be rounded off to next integer where as below 0.5 shall be rounded off to previous integer.
- 8) **Pro Rata Penalty:-** Ferric Alum Grade-4 confirming to IS-299 supplied should be having minimum 16% (% by mass) (Al<sub>2</sub>O<sub>3</sub>). For supply having less than 16% (Al<sub>2</sub>O<sub>3</sub>) by mass content, Pro Rata deduction shall be effected on the basis of landed value of particular invoice as under:-
- If the (Al<sub>2</sub>O<sub>3</sub>) is below 16% but up to 13% Pro Rata deduction will be effected on the basis of landed value of particular invoice.
  - If the (Al<sub>2</sub>O<sub>3</sub>) content below 13% material may be rejected.
  - In case of (a) you will not be allowed to take back of material for replacement.
- 9) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
