1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31/03/2022 for **schedule1 and schedule2 independently**.
  - A) Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31/03/2022 shall be at least 30% (5.79 Lakhs) of the estimated cost supported by the audited annual accounts of each year for schedule1.
  - B) Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31/03/2022 shall be at least 30% (8.29 Lakhs) of the estimated cost supported by the audited annual accounts of each year for schedule2.
  
2. Bidder shall have successfully completed similar works for schedule1 and schedule2 independently.
  - A) Bidder shall have successfully completed similar works for **Schedule1** during last 7 (Seven) years ending on 31.03.2022 as per any one of following:

B) Bidder shall have successfully completed similar works for **Schedule2** during last 7 (Seven) years ending on 31.03.2022 as per any one of following:

a) Three(3) similar completed works costing not less than the amount equal to 40% (11.06 lakhs) of the estimated cost

or

b) Two (2) similar completed works costing not less than the amount equal to 50% (13.82 lakhs) of the estimated cost

or

c) One (1) similar completed works costing not less than the amount equal to 80% (22.11 lakhs) of the estimated cost
