i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs. 11,27,950.00/-

b) Two similar completed works each costing not less than the amount equal to Rs.7,04,969.00/-

Or

c) Three similar completed works each costing not less than the amount equal to Rs.5,63,975.00/-

“Similar work” means experience in Maintenance Contract for Floor cleaning work OR Machine cleaning works OR House Keeping work of Building Maintenance. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate/ Running work shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.

ii) Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

i. Trade License issued by the local authority in the name of the Firm OR

ii. Incorporation Certificate of the firm clearly mentioning office address OR

iii. Electricity bill for last one year in the name of the Firm OR

iv. GSTIN registration

v. Udyam/MSME/NSIC/SSI

ii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financial year i.e. 2021-22 should be at least Rs.4,22,981.00/- lakhs. Annual Report containing Profit & Loss account and Balance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted. IN ADDITION to above

iii) Licence/ Labour Registration Certificate should be registered with the State of Jharkhand only.

iv) GSTIN should be registered with the State of Jharkhand Only.

v) MSME should be registered with JHARKHAND only within the range of EAST Singhbhum, West Singhbhum, Saraikela and Khaireswa Districts.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
