E-Tenders are invited in two parts (Part-I techno commercial part & Part-II Price part) - by the Competent Authority of Uranium Corporation of India Limited, Jaduguda from bonafide, reliable, experienced and resourceful contractors for execution of following work.

Pre-Qualification Criteria for the Bidders:

- i) Average Annual financial turnover during last three years ending 31st March of the Previous financial year, should be at least Rs. 5,00,740/-.
- ii) Experience of having successfully completed similar works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
 - a. Three Similar completed works costing not less than an amount equal to Rs. 6,67,653/-
or
 - b. Two similar completed works costing not less than an amount equal to Rs. 8,34,567/-
or
 - c. One similar completed work costing not less than an amount equal to Rs. 13,35,306 /-.
- iii) Bidder shall furnish a copy of valid license of High Tension Lines (**Up to 33KV Line**) issued to his supervisor by State Government Licensing Board.
- iv) Bidder shall furnish PAN, GST and PF Registration Number, IT returns of the last three financial years, Balance sheet and Profit and Loss statement of the last three financial years.

Similar Job means "Erection, Installation & Commissioning work or maintenance job of Overhead line of Voltage level from 6.6KV to upto 132KV."

Documentary proof of all the above documents to be uploaded along with tender. No tender will be accepted by Post / Courier.

The intending tenderer shall upload necessary documentary evidence to prove their past experience, work order copy along with completion certificate, capabilities and financial resources to do such type of works.



Subsequently, the hard copy of this valid exemption certificate shall be submitted at the office of the Addl. Manager (Pers.), Narwapahar on or before 26.07.2023 at 03:00 PM in a properly sealed condition in separate envelope super scribing the Tender No., Tender Closing date, Name of the Work & Name & Address of the Bidder.

The eligibility is to be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of poor response, with a view to increase the competition, admission of additional documents to meet the Pre-Qualification Criteria may be allowed subject to the condition that

- a) 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- b) The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
- c) The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.
- d) The opportunity of submission of additional documents will be given to all the bidders.

The Corporation reserves the right to accept or reject any or all tenders either in full or part thereof or to split up the work if necessary without arranging any reasons whatsoever.
