E-tenders are invited in two parts (Part-I Technical part & Part- II Price part) by the Uranium Corporation of India Limited, Jaduguda from reliable, experienced and resourceful contractors for execution of following work:

PRE-QUALIFICATION CRITERIA (POC) OF TENDERERS:

Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- i) Experience of having successfully completed **similar work** during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to **Rs.7.09 Lakhs**
Or
 - b) Two similar completed works each costing not less than the amount equal to **Rs.4.43 Lakhs**
Or
 - c) Three similar completed works each costing not less than the amount equal to **Rs.3.54 Lakhs**

Similar work means experience in carrying out maintenance / servicing / overhauling of heaters / furnaces of minimum 200 KW rating OR other maintenance related to heating elements etc. OR any mechanical job of industrial fabrication and erection etc. OR Any type of miscellaneous electrical repairing or electrical maintenance jobs in any organization. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate from the client as documentary evidence in support of their experience / credential failing which offer shall be summarily rejected. **The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.**

- ii) The tenderer's average annual turnover during last 03 financial years, ending 31st March of the previous financial year should be at least **Rs.2.66 Lakhs**. Annual Report containing Profit & Loss account and Balance Sheet duly Certified by Cost / Chartered Accountant for last 3 financial years must be submitted.

Subsequently, the hard copy of the original instrument of cost of tender fee only shall be submitted at the office of **Manager (Pers.), UCIL, Turamdih Mines** on or before **23/05/2024, 12.00 Noon** failing which the offer shall be rejected.

Tenders received without earnest money are likely to be rejected. Tenderer shall remit the EMD by way of DD/Bank Guarantee/Banker's Cheque only in favour of Uranium Corporation of India Limited. In case of registered units with MSME/NSIC/Director of Industries of State, Cottage Industries approved by the State Authority or any other entity as may be specified by Govt. guidelines from time to time proper and valid certificate as documentary proof shall be uploaded at CPPP website <https://etenders.gov.in/eprocure/app> for exemption from submitting Cost of tender fees and/or E.M.D. Subsequently, the hard copy of this valid exemption certificate may be submitted at the office of **Manager (Pers.), UCIL, Turamdih Mines** on or before **23/05/2024, 12.00 Noon** in a properly sealed condition in separate envelope super scribing the Tender No., Tender closing date, Name of the work & Name of bidder.
